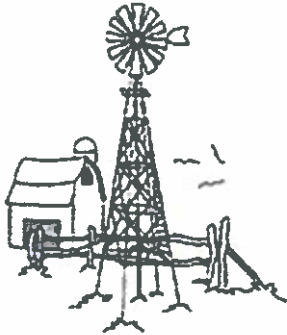


Millersburg Town Council Meeting

Jim Winkler made a motion to pay bills. The motion was seconded by Austin Turner and upon a voice vote was approved unanimously.


Jim Winkler made a motion to adjourn. The motion was seconded by Austin Turner and upon a voice vote was approved unanimously.
